

## **Decision No. (49) For 2019**

### **On the reconfiguration of the Advisory Committee for medical professionals licenses Review**

President of the Supreme Council for Health:

National Health Regulatory Authority:

Having considered the Decree-Law No. (7) for the year 1989 concerning the practice of the profession of medicine and dentistry,

Law No (38) for the year 2009 establishing the National Health Regulatory Authority, as amended by Legislative Decree No. (32) for the year 2015,

And the decision of the President of the Supreme Council of Health No. (7) for the year 2015 on the Advisory Committee for Medical Licenses for Medicine and Dentistry,

Resolution No. (21) of 2017 on the restructuring of the Advisory Committee on Medicine,

Based on the CEO's presentation

Decided the following:

#### **Article (1)**

The Advisory Committee on Medical Licenses for National Health Regulatory Authority shall be reconstituted as follows:

1. Representative of Gulf Arab University as President
2. Representative of the Royal College of Surgeons - Bahrain Medical College as Vice President
3. Representative of Training / Credential Committee on Salmaniya Medical Complex as a member
4. Representative of Training / Credential Committee on King Hamad University Hospital Member
5. Representative of the Training / Credential Committee of the Military Hospital
6. Representative of the Mohammed bin Khalifa Centre for Cardiology Member  
Member
7. A representative of private facilities as a member
8. Representatives of the National Health Regulatory Authority

### **Article (2): Member and Rapporteur**

The Committee shall exercise its powers and its working procedures in accordance with the provisions of the decision of the President of the Supreme Council of Health No. (7) for the year 2015 regarding the Advisory Committee for Medical Licenses for Medicine and Dentistry. In particular, the Committee shall have the following:

- Consider the applications for the license of the consultant doctors
- Consideration of requests for amendment of the classification of the category of a physician from a specialist to a consultant level.
- Consideration of appeals against the classification decision issued

The Committee shall be subject to the supervision of the CEO of the Authority, and the term of its membership shall be one year from the date of issuance of this resolution.

### **Article (3)**

Each member shall disclose in writing to the Chairman of the Committee prior to the meeting the existence of any personal interest, directly or indirectly, that may conflict with the requirements of his membership on a subject before the Committee or the existence of a degree of kinship, marriage or marital relationship, Orally and in the minutes before the consideration of the matter.

As a result of the disclosure of conflict of interest, the member shall abstain from attending the meetings or deliberations of the Committee on the subject matter of the case.

### **Article (4)**

The Chairman of the Committee shall implement this Resolution and shall act as of the date of its issuance. "Any text inconsistent with the provisions of this Resolution shall be repealed.
